# **Listed Site Database Search Results for East Waterway Associated Drainage Basins**

#### Introduction:

Sites listed in federal and state environmental databases were queried to provide supplemental information potentially useful during source tracing activities within the East Waterway (EW) watersheds. The database queries were conducted by Environmental Data Resources in December 2009. The database information is not necessary to characterize current stormwater or combined sewer overflow (CSO) discharges to the EW, because these discharges have been characterized directly, including any potential contributions from cleanup sites located within the storm drain (SD) or CSO basins.
